**DESCRIPTION:** As of October 1, 2018 Pennsylvania is updating the building codes from the 2009 to the 2015 version for all of the International Code Council Codes – residential and commercial. The focus of this presentation is the International Building Code (IBC) which addresses all commercial structures. (Note that the city of Philadelphia has adopted the 2018 version of the Codes as per special exception in the PA legislation. A separate training session will be scheduled specifically for the city of Philadelphia.)

There have been many changes that are reflected in the 2015 IBC that help make concrete masonry more competitive. This presentation will review these changes including changes to concrete masonry unit web requirements, the updated unit strength table, and more that will show greater efficiencies for the masonry walls in many aspects which makes for a more affordable wall with greater energy efficiency. You will see designs illustrating the impacts of new versus old code requirements and visually be able to see the difference and the cost competitive advantage of concrete masonry vs. wood and steel and any other concrete system.

Our expert presenter will answer your questions on site as well so that you are comfortable with this new information and how it will impact your business.

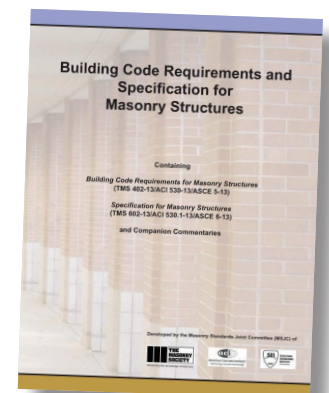
